Be on the Lookout - Tech Support Scams

You might have gotten a phone call, email, or a pop up telling you there's something wrong with your computer. Often scammers are behind these notifications and trying to gain access to your money, personal information or access to your files. These scammers pretend to be from wellknown tech companies, like Microsoft or Geek Squad. They might overuse technical terms to convince you that the problems they "detected" are real.

Some red flags that you are talking to a scammer:



They will ask you to give them remote access to your computer. This will allow them access to all the information stored on the computer.



They will install malware. This will give the scammer access to your computer and the sensitive data on it. like usernames and passwords.



They will try to sell you software or repair services that are useless or are actually free. They may also try to enroll you in computer warranties.

They will ask you to pay with a credit card or gift card for the services they provided that are free in other places. They may also direct you to websites and ask you to enter the card information, your bank account information, or other personal information. This website will direct all the information you input straight to the scammer.

If you think you have fallen victim to a Tech Support or any financial scam, immediately call us, your other financial institutions, your credit card company and the police!
